#### Term Account & Refunds.

Customer agrees that this is an 24 month agreement paid for MONTHLY at current rate of \$20mo & upon acceptance and after 7 days of charge that is sale is final and no refunds are made whatsoever.

Monthly rate is subject to change to adjust for discounts applied, Total monthly charge may vary due to other features added by customer i.e. Anti virus, Extra emails or space and to include any additional features added by customer.

Global411 provides its customers with the option of receiving discounts for entering into a 24 month agreement with Global411 to receive Internet access as outlined in the "Acceptable Use Policy". If the customer is unsatisfied with the Internet service for any reason within the first seven (7) days of service or renewal, the customer may cancel and receive a full refund minus setup fees. Account holder agrees to automatic renewal for an annual account.
